### How Dry Cleaners Can Dispose of PERC Hazardous Waste and ...

Dry cleaners using perc should not put separator wastewater into a septic system, storm sewer or surface water, and it should not enter the sanitary sewer (via sinks, toilets or drains). Dry cleaners can manage separator wastewater by drumming the wastewater and shipping it offsite to a hazardous waste facility.

### BEST MANAGEMENT PRACTICES FOR PERCHLOROETHYLENE DRY CLEANERS

Perchloroethylene is a colorless liquid used primarily in industrial settings for dry cleaning and degreasing metals. This chemical is also used in the production of fluorinated compounds, as a solvent for cleaning and degreasing, and in lubricants, adhesives, and sealants.
