Guide to Completing Form DS-2029 Application for Consular Report of Birth Abroad of a Citizen of the United States of America. Enter the name of the child as it is recorded on the local birth record. Marriage status of parents: List all marriages prior to the birth of the child or prior to the marriage of the child's parents, whichever is appropriate.

A Consular Report of Birth may be issued for any U.S. citizen child under age 18 who was born abroad and who acquired U.S. citizenship at birth. Only the child's parent or legal guardian may make application on the child's behalf.

The U.S. Embassy requires applicants to complete page 2 of the CRBA application (DS-2029) accurately. The parent transmitting U.S. citizenship to his or her child should list the exact dates of physical presence in the United States.

A passport application for the child may be submitted at the same time. The process for scheduling an appointment for a Consular Report of Birth Abroad includes completion of a checklist followed by completion of Form DS-2029. Once completed, we ask that you send us an email attaching the checklist, Form DS-2029 and the documents identified on page 1 of the checklist to us in order to schedule an appointment.

Eligibility for a CRBA | U.S. Embassy in Ghana

Consular Report of Birth Abroad (CRBA) applications are taken by appointment only. If you were given 90 days to provide additional evidence, please schedule a new appointment selecting the option apply for a second passport. We require the CRBA application DS-2029 filled on computer and printed or by hand on one-sided pages only.
