In November 2017, the new ISO/IEC 17025 "General requirements for the competence of testing and calibration laboratories" has been published by the International Standardisation Organizations ISO and IEC. The transition period to the new international standard for laboratories was determined by 30 November 2020. At the end of the transition period, the accreditation of a laboratory shall be based on ISO/IEC 17025:2017.
